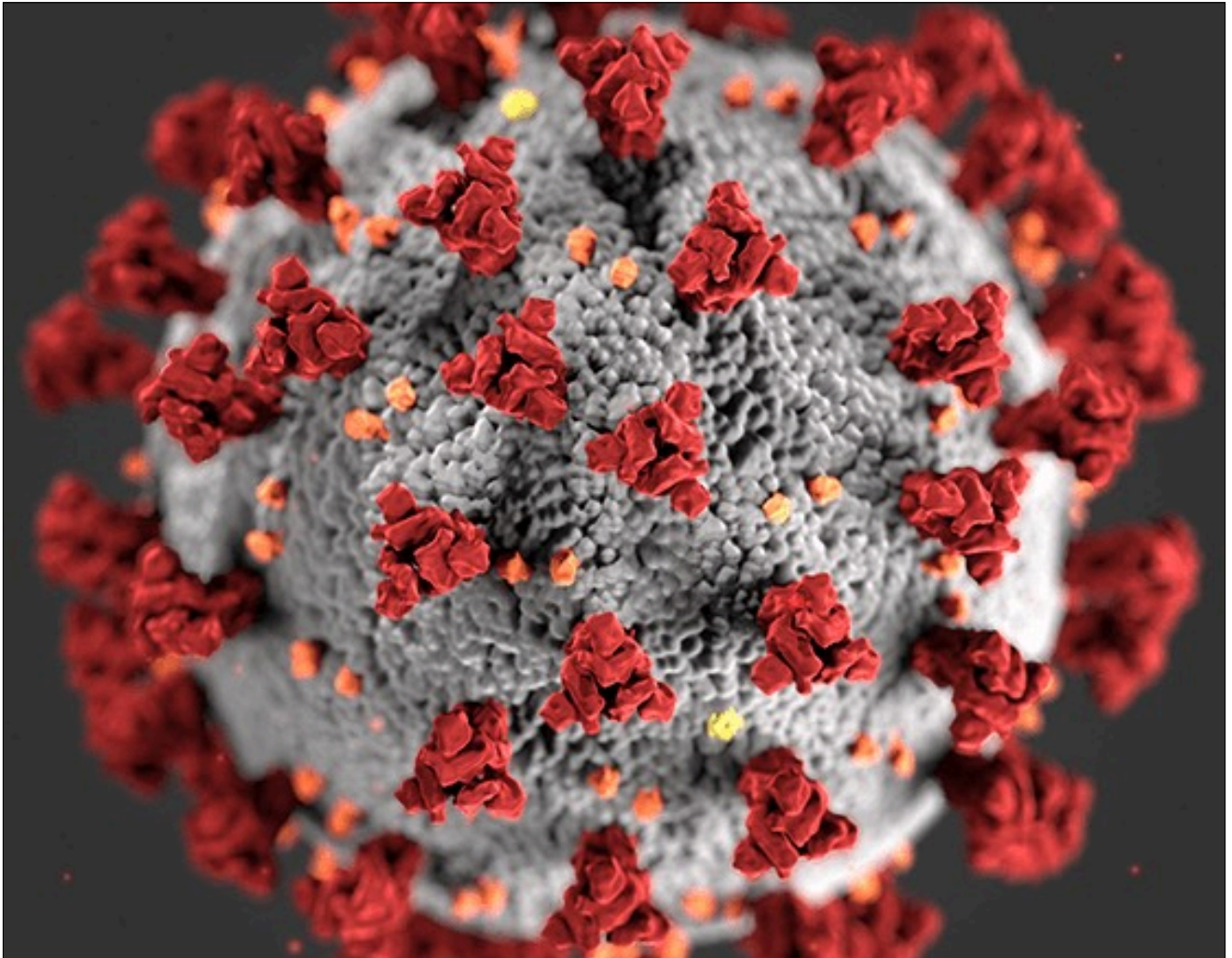

## SHADYSIDE LOCAL SCHOOL DISTRICT

### GUIDING PRINCIPALS

- The Goal of Shadyside Local School District is to support the academic, social, emotional, and physical needs of our students and staff. Many factors contribute to the educational options for the 2020-21 school year.
  - National, state, and local health officials and leaders make health decisions. All operating procedures will be considered with guidance from the Governor, the Ohio Department of Health, the Ohio Department of Education, the Belmont County Department of Health, and the Shadyside Local School School District.
  - Equity and Access for all students.
    - Teacher directed learning for all hybrid/online options for students.
    - Internet connectivity and devices to help the educational process for students.
    - Social-emotional balance and care.

### 20-21 LEARNING OPTIONS FOR STUDENTS

#### **Parents can choose the option that is best for their child.**

1. Face-to-Face Instruction in our buildings five days per week or a Hybrid schedule. A Hybrid Schedule would be implemented if conditions in the district warrant.
2. Remote Learning from home - Students will be enrolled in our online curriculum offerings through Odysseyware. The student will be required to utilize this curriculum the entire semester if this option is chosen.
3. Remote Learning from home using Zoom and Google Classroom. Student will be expected to follow building schedule. When using this option you are expected to be enrolled 9 weeks at a time. Parents please contact your individual building for remote learning expectations.

### 20-21 START OF SCHOOL

#### **School will start for students on August 25, 2020**

- The first week will be an orientation for students regarding health, safety, and educational resources that will be utilized throughout the year. Students will be split into two groups: **(Group A/Group B)** for orientation week.
- **Group A (alphabet A-L)** will attend school on Tuesday August, 25 and Wednesday August 26.
- **Group B (alphabet M-Z)** will attend School Thursday August, 27 and Friday August 28.
- Staff will start on August 17th and begin to set up Google Classroom and plan for our three levels of schooling this year.
- Shadyside Local School District has purchased a Chromebook for each student and teacher in our District. This purchase will allow our students to access our classroom and curriculum on these devices if students are not able to attend face to face or the District is forced to deliver instruction remotely. Due to COVID 19 the Chromebook may not arrive by the start of school. However Google Classroom can be accessed through any internet capable device.

### COMMUNICATION

- ▶ Communication between the District and Parents will be essential more than ever this school year. The way we deliver instruction can change overnight in our three buildings.

### MASK/FACIAL COVERING POLICY

- ▶ Staff are required to wear a mask or facial covering.
- ▶ Masks/facial coverings will be required for all students grades K-12.
- ▶ Every effort will be made to maximize physical distancing throughout the school, in classrooms, and on buses. Masks will be required at all times.
- ▶ Students using school transportation are **required** to wear a mask or facial covering.

### CLEANING AND SANITIZING

Shadyside Local School has committed thousands of dollars to sanitation products to protect our staff and students from the spread of the Covid-19 Virus.

These products and procedures include:

- ▶ Touch less hand sanitizers in every classroom and entrance in our district.
- ▶ Spray bottles with disinfectant in every classroom to sanitize desks in-between class changes.
- ▶ Purchased 5 Battery operated Electro-static machines and sanitizer for deep sanitizing daily. The three building, Field house, and Bus garage have this machine.
- ▶ Custodial plans that include cleaning restrooms every 15 minutes throughout the school day. The electrostatic machines will be utilized before and after school to deep clean each building.
- ▶ Buses will be sanitized after the morning and afternoon routes.
- ▶ Purchased masks for every student and staff member in the district.
- ▶ Purchased a face shield for every staff member in the district.
- ▶ Purchased gloves for staff.
- ▶ Plexiglass shields will be installed in each office.

*5 days (Monday through Friday) of face to face instruction in buildings as traditional as possible while practicing social distancing.*

**Plan may apply to building or entire district**

- Parents assess student health before school.
- Face masks will be required at all time.
- Students using school transportation are required to wear face masks
  - Noncompliance will result in the denial of transportation
- Social distance as much as possible.
- Additional cleaning of surfaces.
- Non-Touch Hand sanitizers in every classroom and at each building entrance.
- Lunchroom expands to other areas of the building.
- No visitors or volunteers.
- No shared student supplies.
- No locker stops.
- One-way hallways when possible.
- No field trips.
- No large group student events.

## **Hybrid Plan - Level Yellow**

### **50% of Students in Building at a Time**

*Students divided into two groups and attending school in person for face-to-face instruction 2 days a week and learning remotely from home 3 days a week.*

- Monday all students would be remote. Monday will be used for teachers to address questions that students may have.
- Group A (**alphabet A-L**) will be face to face on Tuesday and Wednesday while group B would utilize Google Classroom and Zoom to virtually attend class these days.
- Group B (**alphabet M-Z**) will be face to face on Thursday and Friday while group A will be attending virtually these days.

#### **Plan may apply to building or entire district**

- Parents assess student health before school.
- Face masks will be required at all times.
- Students using school transportation are required to wear face masks.
  - Noncompliance will result in the denial of transportation.
- Social distance as much as possible.
- Additional cleaning of surfaces.
- Hand sanitizers in every classroom and at each building entrance.
- Lunchroom expands to other areas of the building.
- No visitors or volunteers.
- No shared student supplies.
- No locker stops.
- One-way hallways when possible.
- No field trips.
- No large group student events.
- Special education services may be adjusted.

## **Remote Plan - Level Red**

### **All Students Learn From Home**

*Remote Learning for all students at home.*

- *Teachers will teach classes virtually utilizing Google Classroom and Zoom*

#### **Plan may apply to building or entire district**

- No field trips.
- Special education services may be adjusted.

**Attendance:** Taken daily during Zoom.

## DISTRICT GOALS

Our goal is to begin the year at the Level Green, learning level scenarios will change based on COVID 19 circumstances.

### **Level Green - All In**

We will be operating 5 days per week practicing as much social distancing as possible. Students accessing Google Classroom and Zoom are expected to maintain the building schedule.

### **Level Yellow - Hybrid**

On Monday's all students in the district will be remote. Students will be expected submit questions to their teachers via Email or Google Classroom.

Group A (**alphabet A-L**) Will be face to face Tuesday and Wednesday.

Group B (**alphabet M-Z**) will be face to face Thursday and Friday.

While the group that is in class face to face, the other group will be expected to log on to Zoom to view the lesson.

### **Level Red - Remote**

All Students will be expected to utilize Google Classroom and Zoom for their lessons.

**Determining what level we will be operating on will be decided on through consultation with Belmont County Health Officials. No matter what level we will be operating on there will be no visitors in the buildings. If something needs to be dropped off to your child you can ring the buzzer at the building and communicate with the Office.**

### HOUSE BILL 164 TELEHEALTH

One of Ohio's top priorities is to support the mental health and well-being of all Ohio's students. Ohio Department of Education licensed providers deliver mental and behavioral health services to both students with disabilities and general education students. Additionally, schools may partner with healthcare providers and community organizations to deliver these services to students.

Another priority is to ensure students with disabilities identified under the Individuals with Disabilities Education Improvement Act (IDEA) not only receive the educational services specified in their individualized education programs (IEPs), but also appropriate related services. Related services include, but are not necessarily limited to, those provided by a speech-language pathologist, occupational therapist, physical therapist, educational audiologist, school psychologist, school nurse or school social worker.

On June 19, 2020, Governor DeWine signed House Bill 164 of the 133rd General Assembly. Section 5 of this new law which permits all school providers to use Telehealth for the entirety of the 2020-2021 school year.

Shadyside Local School District remains committed to providing services including all related services in the most appropriate format based on current health needs. If students are either fully or partially receiving specially designed instruction through a remote learning option Telehealth services will be utilized for related services when they cannot be provided face to face.
